## 6th Grade Field Trip - World of Coca-Cola & The Varsity

## Dear Parents,

Our 6<sup>th</sup> grade students will have an opportunity to go to the **World of Coca-Cola** in downtown Atlanta on **Thursday, April 19, 2018.** We will ride motor coaches to the World of Coca-Cola, tour the museum & interactive exhibits, and eat lunch at **The Varsity** in downtown Atlanta before returning to Lost Mountain.

The cost of the field trip is \$40, which includes the price of transportation on motor coaches, admission to World of Coke, a complimentary soda at the start of the tour, and lunch at The Varsity. While a bit costly, we feel that it will be worthwhile and beneficial experience for our students. Although visiting World of Coca-Cola will be fun, it also provides a unique educational experience that will deepen and expand elements in both the economic and geographic portions of the Sixth Grade Social Studies curriculum.

At The Varsity, students will receive a lunch voucher that includes a choice of one hot dog or hamburger selection, an onion ring or French fry, and a drink (medium soft drink, chocolate milk, or a small Frosted Orange/Shake).

On the day of the field trip, it is important that students wear clothes that follow the LMMS dress code. Additionally, students should eat a good breakfast since we will not go to The Varsity until after our visit to World of Coke. This will allow us to miss the height of the lunch-rush at The Varsity.

A few sixth grade teachers will be at LMMS with alternate assignments for students not attending the field trip. **Students who choose not to attend the field trip are expected to attend school on that day.** Additionally, students who are ineligible for the field trip (due to the signed behavior expectations from 2/27/18) are expected to attend school on that day.

The \$40 fee for the field trip will need to be enclosed in a money collection envelope, and the envelope placed in a black money drop box at school. Checks should be made payable to Lost Mountain Middle School. Both sides of the attached permission/medical form should be completed and returned to your child's homeroom teacher. The deadline for permission forms and money collection is Tuesday, April 10th. Please DO NOT place the permission form in the money envelope.

No child will be denied an opportunity to attend the field trip because he/she is unable to pay. If you are unable to donate the full \$40, any amount would be appreciated. If you are able to donate more than the requested amount, you may do so. **However, if sufficient funds are not collected before Spring**Break, the trip will be cancelled.

We welcome **parent chaperones**. Chaperones must pay the **\$40** to attend (in addition to the \$40 for their child), supervise a group of up to 10 students and ride the bus. Please complete the attached form if you are interested in chaperoning and send in your payment to be considered. **Please note: Chaperones will be accepted until we reach our allotted quota for both 6A & 6B. <u>All chaperone forms should be returned to Ms. Dawson (Room 605) to be considered submitted.</u>**
